There was a very nice turnout of people and plants for judging in Silverton on November 6 despite there being no seminar scheduled. Ten judges and a handful of visitors were treated to 14 beautiful plants to evaluate. Of those, 8 were nominated for awards and two were granted. Congratulations to Jim Rassmann of Florence, Oregon for his beautifully patterned, very flat *Dracula vampira* 'Vlad the Impaler' which received a HCC/AOS of 76 points and to Theresa and Bill Hill of Hillsview Gardens in Mulino, Oregon

Scott Cameron Seaton was our speaker last month. He is VP of Greenhouse Specialists, Inc. and distributes a number of orchid related materials to the orchid industry.



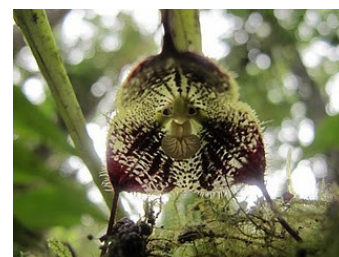

His main presentation topic for the meeting was discussing the benefits of Orchiata bark, which is exported into the United States from New Zealand. It is the bark from Monterey Pine (*Pinus radiata*) trees that has been treated in such a way that it outlasts most traditional bark medias and has a number of other benefits due to the way that it is prepared. 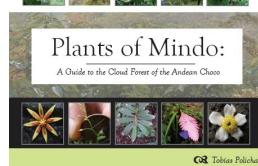

Last month we were lucky in being able to schedule a talk by graduate student Tobias Policha about his research in Reserva Los Cedros, Ecuador. His lecture concerned

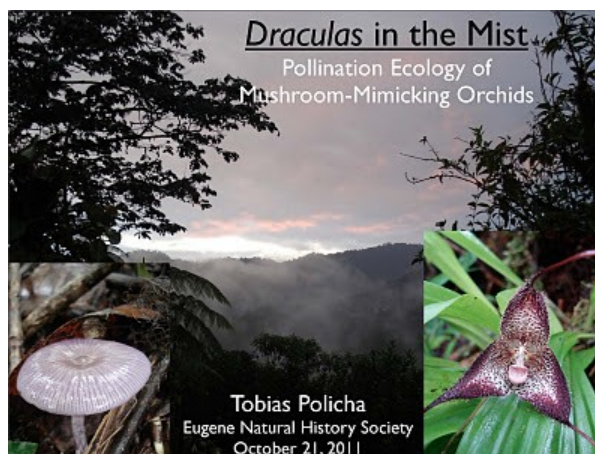


Dracula morleyii showing its mimicry of a mushroom
