CCOS Change of Constitution

As we reported at the October meeting, your board has been working on the process of getting tax exempt status under section 501(c)(3). This would allow us as an organization to accept gifts from individuals that they would then be able to deduct from their taxes. In order for this to happen we are required to make some changes/additions to our constitution. At this time we are proposing the sections highlighted in blue below. The context of the additions can be viewed by opening up the entire draft document on our web site. If anyone has any questions or concerns they can contact a board member via our phone numbers or e-mail addresses noted on the web site. We will vote to ratify these changes at the November meeting.

ARTICLE A. TITLE AND PURPOSE

SECTION 2: The Cherry City Orchid Society is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The following activities will be undertaken to that end:

- A. To educate its members and the public about orchids, orchid conservation, and the process of growing orchids.
- B. To stage an annual show, under the rules of the American Orchid Society, which will be open to the public.
- C. To support the orchid shows of neighboring Societies.
- D. To encourage the training of orchid Judges.
- E. To promote cooperation and good sportsmanship among its members.
- F. To support conservation of orchids and their native habitat.

SECTION 3: The Society shall not be conducted or operated for profit. No part of the net earnings of the Society shall inure to the benefit of, or be distributable to its members, board, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the society shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Society shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

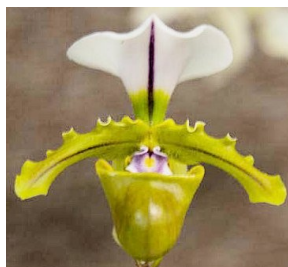
ARTICLE G. DISSOLUTION

SECTION 1: The Society may be dissolved at any time by a majority vote of a special Society meeting called for only this purpose. The quorum at this meeting shall be 2/3rds of the entire Membership. The Secretary shall send written notice of this meeting to the entire Society, a minimum of 2 weeks prior to the meeting. In the event of dissolution of the Society, other than for the purpose of reorganization, none of the assets of the Society shall be distributed to Members of the Society.

The property of the Society will be sold and after payment of the reasonable debts of the Society, any remaining assets will be divided evenly between the local Regional Judging Center and the American Orchid Society in so far as they qualify under the exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Marion county, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

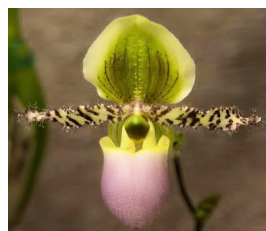
CCOS President's Message

Has everyone got their orchids "in" now for the gray rainy days of Oregon yet to come? I was



hoping for an Indian Summer in October this year, but it was not to be. I resisted transferring many of mine to indoors until the last possible moment - bringing all but my cymbidiums back into my home

about mid October. Before bringing them in I gave them two good sprayings with Bayer Advanced 3 in 1 Insect, Mite and Disease Spray two weeks apart. It comes in a number of forms - ready to use hand spray, hose-end sprayer, and concentrated. Hopefully this will take care of any "critters" that may have decided to



feast on my plants during the summer months and prevent them from spreading onto the rest of my collection during the "in-home" season! I've heard some excellent reports about this product from several orchid growers - so I'm hopeful that I've taken a good step. If you are a home grower and you haven't thought about putting many of your orchids outdoors for the warm season - you should! They really thrive outside and put on lots of new growth. The only challenges are making the lighting transition from indoors to outdoors in the spring and dealing with increased pest issues. — Mike Ayres

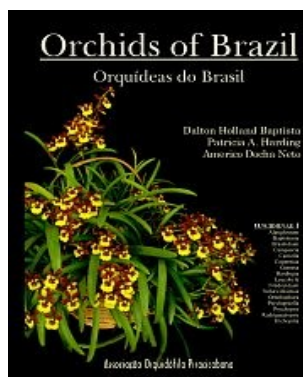
Editor's Note

This first volume covers half of the Oncidiinae of Brazil, most of which are seldom grown in the US.
